A Message From the President

Dear Friends of Bellin College,

As I reflect on our Annual Report 2019-2020, I am proud of the many accomplishments achieved this past year at the college. It was a great year in terms of academic and student initiatives. Together we have taken major steps to move the college forward. Faculty, staff, students, alumni, and friends all found ways to contribute in meaningful ways to our success. We are honored to share our report with each of you. I see how our students' lives can be transformed by the academic and student experiences provided at Bellin College. I am very proud to say I am an alumna of Bellin College.

During the past year, the college received accreditation from the Higher Learning Commission to begin a three-year bachelor's degree in Radiation Therapy. The first class began this fall. This program is one of only two in Wisconsin and this healthcare profession is in high demand. We have received significant support from healthcare organizations and the community for this initiative.

The first class of diagnostic cardiac sonography certificate students graduated in May. We began this program because of the need for skilled cardiac (echo) sonographers. Our graduates were successful with the program and are making a difference in the lives of the patients they provide care to each day. For 2019-2020, we gradated a total of 145 undergraduates and 37 graduate students for a total of 182. With the launch of our Doctor of Science in Physical Therapy program, we expanded the college's reach across the United States. These graduates already have a degree in Physical Therapy and are expanding their knowledge to earn a second doctorate to be able to educate in PT programs.

A Quality Initiative was approved in fall of 2019 by the Higher Learning Commission (HLC) to enhance the First Year Experience for incoming students at Bellin College. This is a five-year initiative and will become a part of our reaffirmation accreditation visit with HLC in 2023-2024. This work is being done by a cross functional team at the college.

We expanded services to the students by offering StudentLife Services, a student-centered program to provide support with mental health needs, financial needs, and counseling which is available 24/7. A mini Micro Market also was installed to provide students food options for all meals during campus hours.



I want to thank our donors and friends of Bellin College. Your continued support provides us the opportunity to grow our programs and meet our initiative to produce excellent healthcare professionals. Our Annual Report highlights many of these accomplishments so enjoy reviewing the successes of this past year. Please consider it your invitation to rediscover everything we have to offer at Bellin College.

A Message From the Board of Trustees Chair

Dear Friends of the College,

In just a few short months, life as we know it for decades has changed almost beyond recognition. Today, we struggle in an effort to coexist with COVID-19.

First and foremost, we express our compassion and support for all whose lives have been disrupted and forever changed by this destructive virus. But these challenging times also remind us what we do at Bellin College matters, perhaps now more than ever. And so we carry on, reflect on the past in an effort to keep perspective on the present.

Imagine being born in 1900.

On your 14th birthday, World War I begins — and ends on your 18th birthday. Twenty-two million people are killed in that war. Later that same year, a Spanish flu epidemic rocks the world and runs until your 20th birthday. Fifty million die from it in those two years.

On your 29th birthday, the Great Depression begins. Unemployment hits 25 percent and the world gross domestic product drops 27 percent.

The financial crisis continues until you are 33. The country nearly collapses with the global economy. When you turn 39, World War II begins. Between your 39th and 45th birthdays, 75 million perish. At 50, the Korean War breaks out. Five million people die.

The worst epidemic in our nation's history — the crippling disease known as polio — erupts when you turn 52. The reign of horror held the country hostage for more than a decade and left tens of thousands affected forever.

At 55, the Vietnam War begins and continues for 20 years. Another 4 million lives are lost in that conflict. On your 62nd birthday, the Cuban Missile Crisis is a tipping point in the Cold War between the Soviet Union and the United States. Life on planet earth as we knew it, could easily have come to an abrupt end.

When you turn 75, the Vietnam War finally draws to an unsuccessful close.

Perspective is enlightening. When caught in the center of a storm, uncertainty and ambiguity keep the horizon far from sight, making it difficult to focus on the future because of the crisis in the present. Keeping perspective allows us to make proactive, purposeful decisions and navigate through the crisis to the horizon ahead.

With the Mission and Vision of Bellin College as our guide, adjusting our sails when and where appropriate, we

will continue to grow and evolve and remain relevant. To all volunteers, donors, staff, leadership team and board members — thank you for joining on this unprecedented journey. Thank you for helping us keep this crisis in proper perspective. Together we will survive the turbulent world of COVID-19 and continue to make a positive and profound impact on our communities and beyond.


